(September 6, 2007) Los Angeles, California, United States District Court

Once again, this office is pleased to report yet another dismissal this week in a complicated federal declaratory relief action brought by the United States Attorney's Office against Jonathan and Lisa Gordon.

On October 12, 2005, the United States of America filed a two count complaint for fraudulent conveyance and declaratory relief against Jonathan and Lisa Gordon alleging that Lisa Gordon's separate property was disguised community property in which the government sought to seize and sell.

If Lisa Gordon lost this case, she would have lost her home with over \$1,000,000.00 in equity. More importantly, her children would have been dispossessed from the only home they have known.

On the eve of trial, Ronald Richards, Esq. invited our prominent colleague Dana Cole, Esq. to join the defense effort by representing Jonathan Gordon. Mr. Gordon is subject to a criminal restitution order. The enforcement of that order constituted the gravamen of the government's lawsuit.

As trial was about to commence this afternoon before the Hon. Valerie Baker Fairbanks, the Central District's newest Article III judge, the government prosecutor indicated to the defense that the office was willing to dismiss the case, agree to never pursue Lisa Gordon or her separate again in connection with this criminal restitution order in exchange for Lisa and Jonathan Gordon releasing the government from malicious prosecution and any Equal Access to Justice attorney fees claim.

The settlement was placed on the record, the case was dismissed, and Lisa Gordon can

sleep easy for the rest of her life that Financial Litigation Unit of the United States Attorney's Office will never bother or harass her again or try and seize and sell her home.

Our hearts and best wishes go out to the Gordon family who has endured 16 months of brutal litigation, depositions, and unbearable expense. The firm would also like thank Dana Cole, Esq. for his immediate integration into the procedural complexities of this matter and for being prepared for trial on such short notice.

A copy of the stipulation to dismiss the case is attached to this summary.

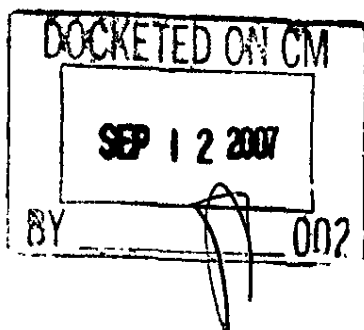
**PROCEEDINGS: COURT TRIAL/SETTLEMENT CONFERENCE**




