


unlawfully conspire together and with another person and persons whose identity is unknown to commit the crime of POSSESSION FOR SALE OF COCAINE, in violation of Section 11351 of the Health and Safety Code, a felony: that pursuant to and for the purpose of carrying out the objectives and purposes of the aforesaid conspiracy, the said defendants committed the following overt act and acts at and in the County of Los Angeles: See Attached.

It is further alleged as to count(s) 1 and 2 that the substance in the above charged offense exceeded 80 KILOGRAMS by weight within the meaning of Health and Safety Code section 11370.4(a) (6).


