1 **JUDGMENT**

2 This action was brought by Plaintiff WVM Holdings, LLC against Defendants Secured  
3 Capital Partners, LLC, a California limited liability company, Victor Franco Noval, individually  
4 and as Trustee of the Rexford Trust, and Jake Noval, individually and as Trustee of the Atlas  
5 Trust. Trial commenced on May 19, 2025. Both Plaintiff and Defendants rested their cases on  
6 June 24, 2025, and the Court issued an oral Statement of Decision that same day, finding against  
7 Plaintiff and in favor of Defendants on all claims.

8 NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that Plaintiff  
9 WVM Holdings, LLC take nothing from any Defendant and Judgment is hereby entered in favor  
10 of Defendants. The Court further finds that Defendants are “prevailing parties” entitled to recover  
11 their costs in an amount to be determined by a timely-filed Memorandum of Costs.
