FAVOR OF PLAINTIFFS
AGAINST DEFENDANT
STEVEN MARK MILLER aka
STEVE MILLER**

The jury trial in this above-captioned action commenced on January 21, 2026, with the Honorable Mark Young, presiding. The jury returned a verdict on January 30, 2026, in favor of Plaintiffs HAIM REVAH and LUCINDA REVAH, as co-trustees of the HAIM REVAH AND LUCINDA REVAH TRUST dated June 2, 2005, and against Defendant STEVEN MARK MILLER aka STEVE MILLER on the cause of action for breach of fiduciary duty in Plaintiffs HAIM REVAH and LUCINDA REVAH's, as co-trustees of the HAIM REVAH AND LUCINDA REVAH TRUST dated June 2, 2005, Second Amended Complaint. This final

1 judgment is entered in favor of Plaintiffs HAIM REVAH and LUCINDA REVAH, as co-trustees
2 of the HAIM REVAH AND LUCINDA REVAH TRUST dated June 2, 2005, against Defendant
3 STEVEN MARK MILLER aka STEVE MILLER as follows:

4 ***IT IS ORDERED, ADJUDGED, AND DECREED***

5 1) Judgment is entered in favor of Plaintiffs HAIM REVAH and LUCINDA
6 REVAH, as co-trustees of the HAIM REVAH AND LUCINDA REVAH TRUST dated June 2,
7 2005, against Defendant STEVEN MARK MILLER aka STEVE MILLER for breach of
8 fiduciary duty;

9 2) Plaintiffs HAIM REVAH and LUCINDA REVAH, as co-trustees of the HAIM
10 REVAH AND LUCINDA REVAH TRUST dated June 2, 2005, are awarded damages against
11 Defendant STEVEN MARK MILLER aka STEVE MILLER in the amount of \$8,750,000.00;

12 3) Plaintiffs HAIM REVAH and LUCINDA REVAH, as co-trustees of the HAIM
13 REVAH AND LUCINDA REVAH TRUST dated June 2, 2005, are awarded prejudgment
14 interest on said damages against Defendant STEVEN MARK MILLER aka STEVE MILLER
15 accruing from September 24, 2021, through the date of entry of this Judgment on February 3,
16 2026, in the amount of \$2,671,355.00. The total Judgment is \$11,421,355.00 (additional
17 prejudgment interest accrues at the daily rate of \$1,678.08 until entry if the Judgment is not
18 entered on February 3, 2026). The Court shall add daily prejudgment interest of \$1,678.08 after
19 February 3, 2026, to the date of signing the Judgment for a total Judgment amount of
20 \$ _____.

21 4) Plaintiffs HAIM REVAH and LUCINDA REVAH, as co-trustees of the HAIM
22 REVAH AND LUCINDA REVAH TRUST dated June 2, 2005, are entitled to post-judgment
23 interest at the legal rate against Defendant STEVEN MARK MILLER aka STEVE MILLER;

24 5) Plaintiffs HAIM REVAH and LUCINDA REVAH, as co-trustees of the HAIM
25 REVAH AND LUCINDA REVAH TRUST dated June 2, 2005, are the prevailing parties against
26 Defendant STEVEN MARK MILLER aka STEVE MILLER and are entitled to an award of
27 court costs pursuant to Code of Civil Procedure sections 1032 *et seq.*, which amounts shall be set
28 by the Court pursuant to Memorandum of Costs; and
